Research Interests

Lay people's behavior in legal contexts

My research investigates the psychological processes that underlie legally-relevant behaviors. I am especially interested in the ways in which juror decision making is influenced by race, ethnicity, and gender, leading to disparities in legal outcomes. My research also examines how lay people's own race, ethnicity, culture, and gender affects their behavior and participation in legal contexts. Finally, I conduct research on jurors' use of complex evidence, such as character evidence.

Gender and race ideologies

My work examines people's beliefs, ideologies, and stereotypes related to gender and race and investigates how those views influence judgments and behavior. I am conducting research on "gender-blind" versus "gender-aware" ideologies and examining how their effects on judgments compare to the effects of the corresponding ideologies for

race. I also am interested in how “princess culture” influences women’s beliefs, behaviors, and interest in pursuing gender non-traditional fields.

Stereotyping, prejudice, and discrimination

I also conduct basic and applied research on stereotyping, prejudice, and discrimination, focusing on the psychological processes that underlie bias. Recently, I have been conducting research on tolerance of racism, a passive form of bias in which people accept or excuse racist behavior in others. Over time, my work has examined biases in several applied contexts, including juror decision making, employment decisions, health judgments, and the Hurricane Katrina diaspora, as well as cultural influences on stereotyping processes.
